can Bloodhound Club, an honorary deputy sheriff in Pierce County, Washington, and a founding member of the Northwest Bloodhound Search and Rescue organization. His dedication to bloodhounds, participation in man trailing, and support of dog and handler trailing teams will long be remembered.

PRBC hosted the Ninth Annual Clyde Reed Memorial Trailing Trial on August 19 - 21, 2016, in Enumclaw and Auburn in conjunction with the

Northwest Regional Specialty and supported entry weekend with the Olympic Kennel Club shows. The weather was quite warm, so trails were planned to be run earlier in the day to avoid the afternoon sun and heat, as well as not to conflict with those participating in and attending the conformation shows.

# 2016 ABC Northwest Agility Trial Hosted by Pacific Rim Bloodhound Club

Per AKC agility trial regulations, "the purpose of AKC agility trials is to afford owners the opportunity to demonstrate a dog's physical ability/soundness and willingness to work with its handler under a variety of conditions. Agility results in a better rounded, conditioned dog, provides good basic training for search and rescue dogs, demonstrates good training and citizenship and has excellent spectator appeal."



Summer 2016 marked the second annual Northwest agility trial offered by the Western Washington Hound Association and the ABC, hosted by PRBC, and chaired by

Cindy Wolfrom. The Argus Ranch facility in Auburn (site of the 2005 ABC National Specialty) was the location of the trial, which brought an excellent entry of dogs (330 on August 27 and 260 on August 28) competing in a dazzling array of classes: Standard Agility, Jumpers with Weaves, Time 2 Beat, FAST, and many more. A favorite competitor for PRBC among the bevy of entered dogs was Lula, an all-American dog (mixed breed), owned by Teresa Mullens, who confirmed that Lula is ... yes! a bloodhound mix. Lula competed in Standard Agility Excellent, Time to Beat, and Jumpers with Weaves Excellent. Agility obstacles included a variety of jumps,

tunnels, chutes, a pause table, weave poles, a seesaw, a raised dog walk and an A-frame. Leashes were left at the starting gate, and the dogs negotiated these obstacles with remarkable speed.

It will come as no surprise to hear that this highenergy event requires willing workers to make everything run smoothly. PRBC's Cindy Wolfrom, Suzi Paine, Becky Irving, and Lynn Harty were on hand to provide club support and sweat equity, working the classes as gate keepers, leash runners, chute "floofers," and bar setters. We are already looking forward to hosting agility in 2017.
