

Memorial Weekend 2022: Thirteenth Annual Clyde Reed Memorial Trailing Trial and the ABC Northwest Regional Specialty, Hosted by the Pacific Rim Bloodhound Club

Over Memorial weekend 2022, members of the Pacific Rim Bloodhound Club gathered for the ABC's 2022 Northwest Regional Specialty in conjunction with Spokane Kennel Club's all-breed dog shows at the Spokane County Fair and Expo Center. Not only were show bloodhounds in the spotlight: trailing teams were on hand for PRBC's Thirteenth Annual Clyde Reed Memorial Trailing Trial.

Memorial weekend weather can be sketchy in the Pacific Northwest, and this year was no exception, with rain showers breezing in and out throughout the weekend. However, there were no drenching downpours, and the daily temperatures, although cool, weren't unpleasant and made for nice trailing conditions.

Event hosts Sid and Lynn Harty welcomed PRBC members and friends from various points around the compass, some of them far-flung. Top distance-traveled honors went to club members Aldo and Diane Branch from San Jose, California, Janet Kelly from New Jersey, and Jan Rothwell from New Hampshire. These folks all traveled many, many miles by air and by land to support the weekend events.

Memorial weekend showing results weighed heavily in favor of PRBC members and their hounds. Judge Janet Kelly's Sweepstakes and Veteran's Sweepstakes' winners gave everyone a chance to applaud youngsters "Mojo" (Sheri Whetstine, B. Copeland, and R. Wagner) and "Sequoia" (Cheryl Cromeenes and Marv Newton) and distinguished veterans Elwood (S. Hamil and Lyn Sherman) and Saidee (Aldo and Diane Branch). Other PRBC wins under Judge Lesley Hiltz in Saturday's Best of Breed competition included a BOB, followed by a Hound Group 1, for "Earl," owned by Michael and Linda McDonald, and a BOS, Best Owner-Handled, and Owner-Handled Group 3 for "Ruby," owned by Aldo and Diane Branch. Sunday's showing under Judge Terry Stacy included a Best of Breed for "Lady," (N. Barber and Tina Kocar) and a new AKC championship and a Best Owner-Handled award for "Mojo" (Whetstine, Copeland, Wagner). More show details can be found at the end of this article. After a day of trailing on Friday and regional showing on Saturday, Saturday evening brought ABC and PRBC members together for a spaghetti feed, an ABC regional meeting, and PRBC's annual meeting, where discussion centered around PRBC's hosting of the 2024 ABC Nationals in Ocean Shores, WA. Back to the beach, everybody! The now-famous PRBC rail sale, expertly overseen by Cheryl Cromeenes, rounded out the evening. Due to challenges associated with really large geographic distances in the West and a small number of members who can reasonably gather for events, PRBC's auction fundraiser will move to an online format, and quarterly online auctions are projected to begin as soon as summer 2022.

Next year will bring a change of venue for the ABC's Northwest Regional Specialty, which, in 2023, is planned to take place in western Washington, where most PRBC members live. The timing is right for making this move, which could offer an expanded community-building opportunity for ABC and PRBC members.



Go to https://dogagingproject.org/about-project/ for information on nominating/registering your Bloodhound or any canine and a free saliva kit to collect his/her DNA for genetic mapping. Did you know that humans and canines share 84% of the same genes? Knowledge gained by this canine study may one day aid in the health and longevity of humans.

Meritorious Service Committee: A reminder that this is a year for MSA nominations of a person and a hound for outstanding service to the American Bloodhound Club and/or the Bloodhound breed. Cheryl has MSA forms in hand. Forms are in the last Newsletter and ABC website. Susan "Suzi" Paine Memorial Challenge Trophy for BOB: The ABC Board has approved a new Challenge Trophy in memory of Suzi through a generous donation made by Lyn Sherman (Saddlepeak Bloodhounds). In 2005, Ch. Heather's Knock on Wood "Knotty" won Best In Show at the AKC/Eukanuba National Championship. In honor of his prestigious win, a bronze was commissioned of him, an original piece and presented to Lyn. In honor of Suzi, a dear friend, Bloodhound breeder and AKC judge, Lyn has donated this original bronze as a Challenge Trophy for BOB at ABC Nationals, beginning in 2022.

COMMITTEE REPORTS:

RESCUE COMMITTEE: None.

TRAILING COMMITTEE: Trailing Trial was held Friday, May 27th, 2022. There were three entries, one MTI and two MTX. There were two passes. New MTI is Cheryl Cromeenes and Sequoia. New MTX is Sheri Whetstine and Jelly.

REGIONAL SPECIALITY: Specialty was a great success. Winners in every category. BOB went on to Group 1 and BOBOH went on to an OHG3! Way to go PRBC hounds! Ribbons and prizes were beautiful!

OLD BUSINESS: All old business has been addressed.

NEW BUSINESS:

- <u>ELECTIONS</u>: PRBC Directors are up for re-election. Nominating committee needs to be formed. Request for volunteers. Cindy offered to lead the committee. Lyn offered to be on the committee. Darla offered to be the third committee member.
- <u>SEPTEMBER 2022 TRAILING TRIAL</u>: Cheryl is the chair. We will have a bag of Mr. Groom grooming products and a beautiful handmade sterling silver pendant of a bloodhound in movement. Cheryl showed the items and they will be raffled off on Facebook. Trailing Trial is two one-day trials, September 17th and 18th, with eight trails offered. Judges are Katie Cole, Cheryl Cromeenes, Sheri Whetstine, Corky Watkins, and Cindy Wolfrom. Base will be at the Wolfrom's home in Winlock. Darla will be the chef. Entries open in July.
- 2023 REGIONAL SPECIALTY & 14TH ANNUAL CLYDE REED TRAILING TRIAL: Lynn said that after years of hosting and chairing the Trailing Trial and Regional, it is time for a change. She reported that Spokane Kennel Club's longtime show chair Barb Nelson has been hospitalized and had a stroke a week ago. SKC is in flux, and it is unclear whether they will be able to do shows or to host our Regional next year. Given that the majority of our members are in western Washington, she would like to move the Regional back to the west side. Discussion was held and the general consensus is that the entry would likely be higher if the Regional is in the west. This would benefit both the club and the membership. Discussion of venues ensued. Suggestions were made such as Enumclaw, Puyallup, Elma. Elma is off the beaten path and there are not many hotels available. Enumclaw is in August, outdoors and the weather is typically quite warm. There are more hotel options than Elma. Puyallup is July. It is indoors and there are more hotel options. Much discussion ensued. Request made for someone to offer to chair. Puyallup is the venue preferred by the majority of members familiar with the three suggested. More discussion regarding the Clyde Reed took place, including discussion regarding the onnection with the Regional. They don't have to be at the same time. Much discussion regarding whether we have two trailing trials or just one? Maybe we should have only one next year while we are transitioning back to the west. There are lots of options to explore. Sheri suggests having a designated specialty and just one trailing trial next year. The option for an additional one-day trailing trial is left open. Further discussion on the trailing trail is tabled at this time. Lynn motioned that we have a designated Regional Specialty with one of the Puyallup Shows in July 2023. Sheri seconded. Motion passed unanimously.
- <u>FUNDRAISING</u>: PRBC cannot raise funds for our National until the 2023 National has concluded, but we can raise funds for PRBC. We have many items in our possession which would be available for online auctions. Janet says Suzanne Fitch from Colonial Bloodhound Club is phenomenal at fundraising. Marie will be taking the auction items home and will be photographing them for posting online. Janet suggests having one auction quarterly, with each item running one week to ten days. Janet suggests putting the items on the American Bloodhound Group page (not the members only page). Janet will contact Suzanne when she gets home. Janet and Lynn will work with Suzanne to get started as soon as possible.
- 2024 NATIONAL: PRBC will be hosting the 2024 National, September 15-21, 2024. Sheri Whetstine and Lynn Harty will co-chair. Two venues were under serious consideration, Post Falls, Idaho and Ocean Shores, WA. Because of cost, the decision was made to go back to Ocean Shores. Our National will be earlier in the year, still during the tourist season, but the Shiloh Inn has agreed to offer us off-season room rates. Contracts for the Convention Center and hotel have been signed. Lyn Sherman volunteered to shuttle people flying in to PDX. Strongly suggested for people coming to fly to PDX as opposed to SEA due to travel time. Weather that time of year will be better for people driving. Sheri says at this point we need to start forming committees. Cheryl said if Janet will be her secretary, she will be the Trailing Trial Chair. THANK YOU CHERYL AND JANET! We are moving forward on a potential show secretary, a potential regional judge, and a potential National Sweeps judge. We also are in discussion regarding a Top 20 chair. The National logo is currently being designed. Lynn says that although many things are in flux we are making good forward momentum. Darla has an apparel connection for silk-screening. Lynn made contact today with an embroiderer in Oregon who will do website sales with preorders.

Sheri spoke with Elaine Russell-Rushton who, if her schedule allows, would love to be the show photographer. Discussion was held regarding having obedience and rally at the National. In 2017 we had only one entry, and 2021 had one entry as well. There are no bloodhound people up here who do obedience. Does the extremely low entry warrant the expense of matting and a judge? Much discussion ensued regarding mats, such as storage, weight, condition of mats if we were to borrow. Janet asked if someone could contact Kristi Mann regarding availability of matting. Lyn said she would contact Kristi and ask. Holly suggested perhaps checking with an

industrial store supply companies for an estimated cost or maybe for donation. It was agreed that Holly will check into the cost. Regarding a donation, it was clarified that we are a not-for-profit and NOT a charitable organization, not a 501(c)3. Tina has agreed to do the ribbons for the National.

ADJOURNMENT: With no further discussion Cindy entertained a movement for the meeting to be adjourned. Cheryl motioned. Lyn seconded. Motion passed unanimously and the meeting was adjourned at 8:11 pm.
