Meeting is called to order by President Cindy Partington at 12:25 PM **Cindy:** Minutes of previous meeting were in newsletter, has everyone read. Move to approve as printed. Second. Approved. **Secretary's Report:** Vote in new members Shirley and Larry Walden. **Treasures Report.** Report Read by Cindy sent in by Kay. Money made on Regional, was minimal, made from fundraising, \$700. Need support on Auction items. Barely squeaked by. **Rescue Committee:** Sonnya reports we have three kennels and shooting to have six up soon. A lot of dogs have been denied access into program due to aggression. No dogs in rescue right now, had one to put down due to aggression. Suzi notes she has had 6 or 7 emails from people who are interested, but they rarely follow through. One real application. Suggestion to download the application and send with email response to inquiries. Suzi will start doing that and will go back to those interested and send them out. Some high school kids are doing volunteer work with Sonnya work as far as walking and training. **Nominating Committee:** Reported by Stacey: No additional nominations so the slate will be effective as published. Only change will be addition of Suzi replacing Noel on Board. Board is 2 year term, Katie and Cindy are one year terms. Next year we will be electing President, Vice President, Secretary, and Treasurer. **By Laws Committee:** Cindy: committee received information and will get going. **Old Business.** Trailing Trial in November reported by Suzi Paine: It was very small, two entries, two run, neither passed, but will have another trial in May, Memorial Day weekend. Hartys planning to do 6 trails all in one day. Still considering another trail in fall on West side. Talking about end of August or beginning of November. **New Business:** 2007 regional, NW, Suzi is show chair, Janis Trophy Chair. Judges are set. Stacey has Bill's contract signed. February 2007

Whew! This has been a very busy and crazy time for Rescue. The fall season seemed to be the time of year that everyone wanted to relinquish their bloodhounds to Rescue. Between November and late February, we took in 7 bloodhounds. Several came from humane societies, a few were owner-surrenders, and one was found wandering the streets.

Zoey and Gulliver, aka Elliott, arrived in Rescue together. They were picked up together by the Everett Animal Control. We assume they are brother and sister, and that they are just over a year old.

Elliott was recently adopted by Larry & Janet Law of Gig Harbor. He joins their family which includes Darla, a shih tzu, and Trudy, a beagle. Larry and Janet have a wonderful network of dog-savvy friends and family that are there to support their new bloodhound "habit". Larry is interested in SAR training with Elliott.



Pluto was found wandering the streets of Snohomish. We have suspicions that he came from the same home/breeder as Zoey and Gulliver, as they all have the same appearance, came from the same area, and are the same age. Pluto was placed in Spokane, but they quickly decided that he wasn't a good fit for their family. We are still trying to find a forever-home for Pluto.

Dakota, a 3-year-old female, was an owner-surrender to a Western-Washington humane society, where Katie Cole picked her up. Laurie Adomite is fostering Dakota at her home. Dakota is a beautiful liver and tan female. It is

amazing to have such an emotionally solid, well-mannered dog placed in rescue. We hope that she will do well in whatever family she ultimately finds.



Oliver, a 7-month-old male, was owner-surrendered. He is a little guy who is very intelligent and easy to train. He has severe separation anxiety. After a failed attempt at placing him in a home with a single owner and no other dogs, we realized that he needed to have a home with constant companionship. Chris and Denise Dixon were willing to take him in as a foster with their other 4 dogs. So far it has been a beautiful fit.



Rescue is getting several calls and emails a week about more bloodhounds that need our services. We are quickly becoming over-populated. Tim Crawford, our un-official PRBC Rescue hero, has been building runs and kennels as fast as he can. Because of his efforts, we now have 2 indoor and 5 outdoor runs. The outdoor runs have gravel floors, dog houses and a clear vinyl roof. Plans are in place for 2 more outdoor runs. Currently Zoey, Pluto, and our newest addition, Amos, are being housed in these beautiful spacious new runs.

If anyone is in a position to foster one or more bloodhounds, we are in desperate need of foster homes. These dogs do not have the personality to be kenneled indefinitely, and more and more personality and behavior issues become evident the longer these guys are kenneled. The dogs need a home environment where they can be thoroughly evaluated in a "normal" setting. Please contact Sonnya Crawford (drsonnya@gmail.com) if you can help with fostering.

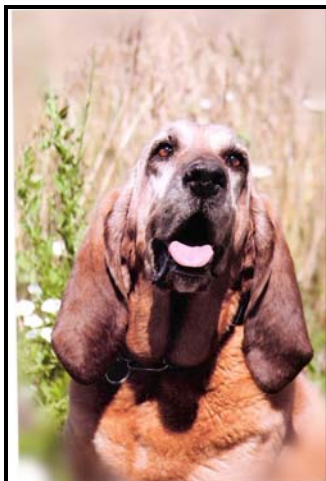

Rainbow Bridge Welcomes Two Beloved Hounds

April 1993—December 26, 2006

Sally Jane entered into this world a very sick little puppy. She came from a "back yard" breeder down in Tennessee who sold her to a puppy mill broker who sold her to a major pet store chain here in Portland Oregon. Her luck changed when the pet store brought her into our veterinary hospital for her pre-sale examination. With one listen to her heart she was diagnosed with a congenital heart defect called Patent Ductus Arterious. The only treatment for this condition is surgery and the pet store was not going to pay for the surgery so she was to be euthanized. Being who I am and working for the wonderful doctors I work for Dr. Dave Barno asked the store owners if he could try to correct the defect and if it was successful we would place her in a home. The store agreed. Several days later Sally under went heart surgery with me manually assisting her breathing and monitoring her anesthesia. She sailed through surgery and recovered as if nothing had ever been wrong. After a full recovery it was decided that I would provide this incredible dog with a home as I did search and rescue. Sally became an inspiration to many. Not only could she trail like no other I've ever seen, she had brains. Others were continually amazed that I worked her off leash many times and that she was allowed to just run around as she would actually come when she was called. I remember a trip to Maryland in april of 2000, where we were a part of a FBI study on the ability of bloodhounds to detect human scent off of materials that had been destroyed in bombs. They had asked 40 law enforcement / SAR hound handlers to each handle an item that was later blown up. We then were given scent that was collected from each item after it was de-

He taught me many things; he was strong and courageous and had a passion for life to his final breath. He was a complex fellow, an ancient soul and my dearest friend. I will always miss him.

stroyed and told to identify the person who had handled it. It was a very fascinating study that is still being worked on. Sally did as she usually did in a lot of situations a worked off line in a lineup situation. All of the handlers there were shocked that I had her off lead. I on the other hand was dumb founded by the fact that they thought obedience training was out of the question for bloodhounds. So it became known that Sally was a bloodhound in body but a shepherd in mind. She also had incredible determination and drive. In her



entire career I never knew her to quit. She never gave the impression that she was tired or couldn't do the job. We had a search in June of 2001 for a lost hiker on the South Sister in Bend Oregon. We climbed the mountain 4 times in a weeks time. Each time starting from the bottom and climbing up to were we had stop the previous climb and continuing on until the snow got to deep to continue. On the third trip up Sally tore a nail and didn't give any indication that she had done so. It wasn't until we got back to the truck and I saw her bleeding the I was aware she had injured herself. The next day we climbed the mountain again and this time she wore a bootie. It never occurred to her that she had an injury that could prevent her from performing her duty. And on that last climb she located the camera and gloves worn by the subject allowing search coordinators to narrow the scope of the search. Lastly Sally was an amazing family dog. She took her family as a mother dog would care for her puppies. No one came between her kids (Garret and Emily) and her. She would put herself between any perceived threat and the kids. I think this was part of her "shepherd" mind.

In May of 2006 Sally Jane was diagnosed with Osteosarcoma in her right shoulder. It was with much thought that I decided to not amputate her leg and to just manage her pain and give her as much love as possible until she indicated it was time to pass on. She, as usual demonstrated her undying strength and will to be with the family. She never let on that she was in pain as she daily played with Brodie and the kids and longed to go with Brodie and I on our training days. Sally held on for 7 months after her diagnosis. We spent Christmas together and the day after Sally gave me that sign I had been dread-

ing. As I held her she made that final journey, and those I had asked to be with her in her final journey reminisced about her courage and her dedication to life. Sally Jane for me will always be that one special partner and companion that I will never forget. She will be one that can never be replaced and every dog that comes after her will be compared to. She was the one dog to change my life and I will always be grateful for the opportunities she had given me.
