3. I agree that I will provide each buyer of my Bloodhounds with accurate records regarding the pedigree and a certificate of health which includes the name, address and telephone number of the attending veterinarian.
4. I agree to provide a written contract/agreement for each sale or service which includes special conditions related to that sale.
5. I agree not to promote indiscriminate breeding practices y using the advertising of availability of "breeding pairs", "stud dogs" or "bitches in whelp" in my effort to sell my Bloodhounds.
6. I agree not to release any puppy to its new owner prior to seven weeks of age or what the local ordinances state.
7. I agree to act in a sportsmanlike manner and not deliberately degrade other exhibitors/breeders or their dogs.
